## How do you become a participant in Spooks and Coupes?

If you (and/or your organization) would like to participate in this event, you will need to:

- 1) Select one or two vehicles that you would like to bring. \*Please be aware that vehicles may be required to park on grass just off paved trail.\*
- 2) You shall be responsible for ensuring that an individual acting on your behalf is with the vehicle(s) at all times during the course of the event. Keys shall not be left in the vehicle's ignition at any time during the event and you must not start your vehicle during the event.
- 3) You are permitted to bring non-alcoholic beverages (water, etc.) for your consumption in the event of warm weather. There will be food vendors on site where you can purchase food and beverages during the evening. *A complementary dinner consisting of pizza, chips, and a drink may be offered by WCPR for WCPR volunteers, vehicle owners, and WCPR staff.*
- 4) WCPR will provide candy and other treats to hand out during the event. Vehicle(s) owners will be asked to pass out the candy and treats provided by WCPR to Trunk-or-Treaters!.
- 5) Vehicle owners are welcome to dress in acceptable Halloween costumes which shall be determined by WCPR (nothing too scary please) and can "trick" out their vehicle(s) to coordinate with the Halloween theme!
- 6) You are responsible for insuring your vehicle(s).
